All India Institute of Medical Sciences (AIIMS) Madurai, Tamil Nadu, an Institute of National Importance is one of the new upcoming AIIMS and apex healthcare Institute being established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) with the aim of correcting regional imbalance in quality tertiary level healthcare in the country, and attaining self-sufficiency in graduate, postgraduate and higher medical education and training.

The Executive Director, AIIMS Madurai invites application in prescribed format from Indian Nationals for the post of **Senior Resident (Non-Academic)** as per Residency Scheme of Govt. of India. The post of **Senior Resident (Non-Academic)** is a **tenure post for duration of 3 years**. DNB Equivalence Requirements :

Applicants holding DNB in broad specialties or Dr NB in super specialties as their essential qualifying education must provide documentary evidence of its equivalence with MD / MS / DM / M.Ch issued by Competent / Appropriate authority as per NMC New Delhi notification dated : 30.06.2025. This evidence must meet the following criteria:

- DNB / Dr NB training should had been done in a medical institution with an attached hospital or in a hospital with 500 or more beds recognized by the National Board of Examinations.
(OR)
- Candidate has done one year of senior residency in a medical college or institution recognized by NMC as teaching institution for that specialty / super specialty after passing DNB / Dr NB in the concerned specialty / super-specialty (In all cases where DNB/Dr NB training was done in a hospital with less than 500 beds)

Candidates with essential qualification being DNB / Dr NB will be eligible if one is meeting either of the above conditions.

- Age will be counted as on the closing date of submission of online application.**
- The appointment to the post(s) is / are whole time and private practice of any kind is prohibited.
- 4% reservation for PwBD candidates on horizontal basis is applicable as per Government Rules.
- The **initial place of posting** of the appointee will be at a temporary campus for AIIMS, Madurai i.e., at **Government Medical College, Ramanathapuram, Tamil Nadu** and shall be shifted based on the progress of the Project of AIIMS Madurai. The decision of the competent authority of AIIMS, Madurai in this regard is final.

13. **Only those candidates who have been declared successful in their qualifying degree exam and will be completing their tenure for the same on or before the closing date of application will be eligible.**
14. In cases where result of qualifying degree exam is declared after the closing date of application, their candidature will stand cancelled and no claim for selection on the basis of interview will be considered.
15. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS Madurai reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules / circulars and requirements. The reservation will be followed as per Government of India Rules.
16. The aspiring applicants satisfying the eligibility criteria in all respect can appear for the interview. The applicants have to report at Temporary Campus of AIIMS Madurai at Government Medical College Campus at Ramanathapuram, Tamil Nadu **along with the duly filled in Application form given as Annexure.** The decision of Executive Director, AIIMS Madurai in this regard shall be final and binding.
17. The offer of appointment when made will be provisional and subject to verification of credentials (Educational & Personal) by competent authority.
18. No correspondence whatsoever would be entertained in this regard.
19. Those who are working in Central / State Government / Semi Government / Autonomous Institution must submit a **“NO OBJECTION CERTIFICATE”** from the present employer at the time of interview.
20. Self-Attested photocopies of Degrees, Certificates, Mark sheets, Age proof, Photo ID, Residential proof, Caste certificates etc. may be annexed to the hard copy of the application and the same shall be produced in original along with photocopy for verification **at the time of interview.**
21. Any Amendment / rectification / change / editing is NOT allowed in Name / Date of Birth / Subject applied / Category i.e. SC/ST/OBC(NCL)/UR/PwBD/EWS status after submitting the application
22. **Caste / Category Certificates:**

(A) OBC Category :

- i. The vacancies are being advertised in financial year **2025-26**, therefore, valid NCLOBC certificate issued during the period **from 01.04.2025 to 31.03.2026** will be considered valid.
- ii. Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36036/2/2013-Estt(Res-I) dated 31.03.2016.
- iii. **Certificate must be valid for employment in Central Government Institutions.** OBC candidate's eligibility will be based on Castes borne in the Central List of Govt. of India. **Their Sub-caste should also match with the entries in Central List of OBC, failing which their candidature as OBC candidate will not be considered.** The OBC certificate should clearly show that the applicant does not belong to the Creamy Layer.

(B) EWS Category :

- i. The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039 / 1 / 2019-Estt (Res), dated 31.01.2019.
- ii. Application under **EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority** and subject to verification of genuineness of the certificate by the issuing authority. As per DoP&T OM No. 36039/1/2019- Estt (Res), dated 31.01.2019, the crucial date for submitting income and asset certificate by the candidate is the closing date of application for the post, except in cases where date is fixed otherwise. **Candidates are required to upload valid EWS certificate based on income of Financial Year 2024-25 and must be valid for the year 2025-26.**

23. For eligibility to applying for these posts, the upper age limit as on closing date will be 45 years.

24. **Age relaxation:**

The upper age limit is relaxable as per rules of the Govt. of India and shall be permissible to candidates only on fulfilment of terms and conditions mentioned in the relevant orders / instructions of the Govt. of India.

* *Age relaxation will be admissible only to those employees working under Central Government not under Autonomous Body / State Government / PSU and working in posts which are in the same line or allied cadres and here a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of duties of the post(s) to which has been advertised. Decision in the regard will rest with the authority of AIIMS, Madurai.*

25. **No age relaxation would be available to SC / ST / OBC / EWS candidates applying for unreserved vacancies.**

26. **All applicants are permitted to apply against the posts earmarked for EWS as unreserved category [hence, if remain unfilled by EWS category candidates, posts will not be carried forward as backlog to next recruitment year] subject to the following conditions:** (i) That their candidature will be considered only if EWS applicants are not available, (ii) That their candidature will be as UR candidate only and hence there shall be no relaxations which are otherwise permitted under their specific category and (iii) application fee will not be reimbursed under any circumstances.

27. The persons belonging to SC/ST/OBC/EWS/PwBD must submit the certificate in the requisite proforma duly issued by the authority concerned (**if applicable**). Reservation and/or Relaxation to SC/ST/OBC/EWS/PwBD/Ex-SM shall be admissible to respective category candidates as per the Govt. of India rules.
28. The upper age limit in case of Ex-servicemen and Commissioned Officers, including ECOs / SSCOs / Government servants, shall be relaxed by Five years' in addition to the relaxation as mentioned above, subject to the condition that on the closing date for receipt of applications the continuous service rendered in the Armed Forces by an Ex-serviceman is not less than six months after attestation. This relaxation is also available to ECOs / SSCOs who have completed their initial period of assignment of five years of Military Service and whose assignment has been extended beyond five years as on closing date and in whose case the Ministry of Defence issues certificates that they will be released within 3 months on Selection from the date of receipt of offer of appointment. Candidates claiming age relaxation under this para would be required to produce a certificate in the prescribed proforma to the Institute at the time of Interview at AIIMS Madurai.

NOTE: Ex-Serviceman who have already secured regular employment under the Central Govt. in a Civil Post are permitted the benefit of age relaxation as admissible for Ex-servicemen for securing another employment in any higher post or service under the Central Govt. However, such candidates will not be eligible for the benefit of reservation, if any for Ex-Servicemen in Central Govt. jobs.

29. **For Persons with Disability (PwBD):**

- i. The candidate must possess a valid document certifying his/her physical disability is conforming to judgment of Supreme Court of India i.e.: "With the approval of the Ministry of Health & Family Welfare, Govt. of India vide letter no.18018/2/2009-ME(P-1)dated 17.02.2009 it has been decided that while providing reservation in admission to medical course in the first instance candidates with disability of lower limbs between 50% to 70% shall be considered and in case candidates are not available in that category, then the candidates with disability of lower limbs between 40% to 50% will also be considered for admission as per decision in the Writ Petition (Civil 184/2005-Dr.Kumar Sourav Vs. UOI & others in the Supreme Court of India".
- ii. The disability certificate should be signed by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals / Institutions & countersigned by Medical Superintendent.
- iii. The constitution of the Medical Board will be one consultant each from disciplines of Orthopaedics, Physical Medicine & Rehabilitation and Surgery.
- iv. PwBD candidates who apply will be considered against seats in category in which he / she has applied i.e. GEN / SC / ST or OBC. Last seat/s in the respective category will be offered to PwBD candidates, (in case PwBD candidate is not able to make on his / her their own merit).
- v. The disability conditions falling under the category "likely to improve" "under temporary disability" category are not eligible for reservation.
- vi. The condition i.e. "progressive, non-progressive or not likely to improve" are to be treated as eligible for reservation.

TERMS & CONDITIONS :

1. Vacancies arising out of non-filling / resignation may be filled in a subsequent notified date through rolling advertisement.
2. The candidate who is already in government service shall submit '**No Objection Certificate**' from the present employer at the time of Interview.
3. Canvassing of any kind will lead to disqualification. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
4. The appointment shall be as per Govt. of India's Residency Scheme. The appointment can be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority. The appointee shall be on the whole-time appointment of the AIIMS and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract. He / She is expected to confirm to the rules of conduct and discipline as applicable to the institute employees. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
5. The total Residency period is of 3 years duration. If the candidate has worked as a Senior Resident in any Govt. medical institution, whether on regular or ad-hoc / Contract basis, the duration of Senior Residency already done will be reduced from the 3 years tenure to be offered. Initial appointment will be one year and extendable based on the satisfactory performance and the service is required by the Institute.
6. Applicants should not have completed 3 years of Senior Residency under Residency Scheme in any Govt. medical institution, whether on regular or on ad-hoc / Contract basis.
7. If an appointee wishes to apply somewhere else or resign within the first 03 (three) months of joining, then neither he/she will be issued a No Objection Certificate (NOC) nor he/she will receive any Relieving Letter or Experience Certificate.
8. The posts of Senior Residents will be regulated as per the provision of Central Residency Scheme. The posts of Senior Resident will be governed by CCS (Temporary Service) Rules.
9. Service under the Institute is governed by that Act and the Rules & Regulations framed thereunder.
10. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
11. The candidate should not have been convicted by any Court of Law.
12. In case of any information given or declaration by the candidate is found to be false or if the candidate has will-fully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any action taken as deemed fit by the appointing authority.

13. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
14. Incomplete applications in any aspect will be summarily rejected.
15. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
16. Leave entitlement of the appointee shall be governed as per Institute Policy.
17. All disputes will be subject to jurisdictions of Court of Law at Madurai.
18. The initial place of posting will be at Government Medical College, Ramanathapuram (Temporary Campus of AIIMS Madurai) and shall be shifted to Madurai based on the progress of the permanent campus construction at Madurai.
19. He / She will have to work in shifts and can be posted on rotation at any place including casualty / ward / OPD / camps organised by institute or Govt or concerned department as per the need / requirement of Hospital Management.
20. Appointment of selected candidates is subject to his / her being declared medically fit by competent Medical Board.
21. All information will be provided through the Institute website only. The Institute will not be responsible in any manner if a candidate fails to visit / access the website in time. Candidates are requested to regularly visit the institute website i.e. <https://aiimsmadurai.edu.in> for updated information regarding the recruitment.
22. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the institute reserves the right to modify/withdraw/cancel any communication made to the candidate.
23. The applicant will be responsible for the authenticity of submitted information, other documents and photograph. Submission of any false and/or suppression/concealment of facts shall lead to rejection/ cancellation of selection/recruitment.
24. No interim enquiries/correspondence/communication of any sort will be entertained on the matter.
25. In case, any information or declaration given by the candidate is found to be false or if the candidate has wilfully suppressed / concealment of any material information relevant to this recruitment, he/she will be liable to be removed from the service and/or action, as deemed fit, may be taken against him/her by the appointing authority.

- h) Certificate for claiming Reservation (SC/ST/OBC(NCL)/EWSs/PwBD) (*For OBC(NCL) & EWS – Certificate should have been issued on or after 01.04.2025*).
- i) No Objection Certificate (NOC) for those Candidates who are working in Central/State Government/Autonomous Institutions/Statutory Organizations/PSUs under Central/ State Govt. on regular basis, *if applicable*.
- j) Self-declaration for no of terms under the Residency Scheme, so far.

27. Shortlisting of candidates: The prescribed qualifications are minimum and mere possessing the same does not entitle any candidate to be called for interview or for selection. Shortlisting of candidates for further process/interview will be done on the basis of educational qualification, relevant experience, caste/category etc. And/or as per the shortlisting criteria decided by the Executive Director, AIIMS Madurai. In case large number of applications are received for any post, screening test may be conducted to shortlist candidates for interviews. Decision of the Executive Director, AIIMS Madurai in this regard shall be final and binding on the candidates.

28. Selection Process :

Interviews will be held at AIIMS Madurai or at any other place and mode as may be decided by the Executive Director, AIIMS Madurai. Candidates called for interview will have to produce all relevant original documents for verification before the interview.

29. No TA/DA will be paid for attending the Written Test / Interview.

30. All information related to this recruitment i.e. Online application procedure, selection procedure, result, corrigendum, addendum etc. will be published on the website of AIIMS Madurai (www.aiimsmadurai.edu.in) from time to time. Hence, the institute will not enter into any correspondence with candidates in such matters. Candidates are advised to regularly visit the website of AIIMS Madurai for updates.

31. Overseas citizen of India (OCI) cardholders under section 7(a) of citizenship act, 1955 are also eligible to apply for teaching post as per ministry of home affairs order no. 26011/52/2016- OCI dated 02nd August, 2018. However, they are not exempted from personal appearance for written exam and or interview for determining the eligibility for selection.

32. The equivalent qualification will be decided by the competent authority of AIIMS, Madurai and his/her decision in this regard will be final.

33. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the institute reserves the right to modify/withdraw any communication made to the candidate.

34. Selected candidates are expected to conform to the rules of conduct and discipline as applicable to the employees of AIIMS Madurai. Other terms and conditions will be governed by the relevant rules and orders that are in force and amended from time to time.
35. Decision of the competent authority of AIIMS, Madurai in all matters regarding eligibility/selection would be final and binding on all applicants/candidates. No correspondence whatsoever would be entertained by the AIIMS, Madurai in this regard.
