- (c) In cases, where selected candidates do not possess apprenticeship in ammunition and explosives, they shall be deployed on work only after undergoing necessary safety and technical scrutiny training imparted by Ordnance Factory Badmal.

7.0 Closing Date for Receipt of Application : 21 days from the date of publication of advertisement in Employment News.

8.0 Remuneration :

- (i) Remuneration will be paid at the rate of 1/30th of the pay at the basis of the relevant pay scale plus dearness allowance for work of 8 hours a day. Proportionate deductions shall be made for unauthorized leave/absence from duty etc. The engaged personnel will be eligible for Company Holidays at par with regular employees.
- (ii) IDA as prevalent will be applicable.
- (iii) House Rent Allowance as per classification of Cities (where Company Quarter is not available).
Note : In case of availability of Company Quarters, priority would be given for allotment of Quarters. License fee for Quarters will be deducted at the rates as applicable to regular employees
- (iv) The performance of the individual on fixed term employment will be evaluated. Individuals having performance rating Poor or below will be given one months' time in writing to improve their performance. After one month again performance will be evaluated and if again the performance rating found Poor or below, the services of the individual will be terminated by giving 15 days' notice.
- (v) Personnel engaged will be eligible for EPF and Employees Compensation Act, 1923 [as amended through EC(Amendment) Act, 2017] as per Act and Government guidelines.
- (vi) Personnel engaged on fixed term basis are eligible to Bonus (if applicable) as per Bonus Act 1965 amended time to time.

9.0 Process of Engagement :

- (i) Selection of the candidates shall be done based on the Marks secured in the Degree and Diploma and personal Interaction/Interview only, in the order of merit & preference.
- (ii) Candidates qualifying in Degree and Diploma and having apprenticeship will be called for Document Verification and personal Interaction/Interview based in the order of merit (Preference & Category wise). Candidates found eligible in Document Verification will be called for personal Interaction/Interview.
- (iii) Cut off percentage for calling candidates for Document Verification and personal Interaction/Interview will be decided by Ordnance Factory Badmal, based on the marks secured in the qualifying examination i.e. Degree or Diploma.
- (iv) Merit list will be prepared based on combine marks secured in Degree/Diploma and personal Interaction/Interview.
- (v) Weightage of Marks in Degree/Diploma and Personal Interaction/Interview will be 85% and 15% respectively.
- (vi) In case of rejection of candidates during the Document Verification process on account of non-availability of requisite documents/testimonials, not meeting the advertised criteria with respect to Age, Qualification, Experience, etc. next candidates will be called for Document Verification and Personal Interaction/Interview in the order of merit (Preference & Category wise).
- (vii) If the candidates in the Merit List found ineligible during any stage of engagement or fails to report within the stipulated time/date, a candidate wait listed and belonging to the same category will be considered instead.

11.0 General Conditions :

12.0 Other Benefits and Terms & Conditions :

- (i) Working pattern of the Tenure based personnel will be the prerogative of the employer.
- (ii) Personnel engaged will be entitled of 30 days Earned Leave (EL) per year. 2.5 days of Leave will be credited for every calendar month of service. Leave can be accumulated by the Personnel during their tenure up to 30 days and can be encashed after completion of one year. For the last month of Service prior to separation / completion of Tenure, the Leave of 2.5 days pertaining to the last month of Service will be credited on the 15th day of that month.

- (v) Tenure based personnel will not be entitled for any other medical benefits in any of the Ordnance Factory Hospitals & Dispensaries or elsewhere. In case of an emergency, facilities in Ordnance Factory Hospitals/ Dispensaries can be availed.
- (vi) Tenure based personnel will be entitled for safety and protective gears, equipment, kits etc. as per the Company norms.
- (vii) Female personnel will be entitled to Maternity Benefits as per the provisions under the Maternity Benefit Act, 1961.
- (viii) Engagement of Tenure based Personnel shall be on contract basis initially for a period of ONE year which may be extended up to a maximum period of FOUR years from the date of engagement (including initial period) based on factory requirement and individual's performance. The tenure will come to an end automatically on completion of four years period from the date of joining, without any further notice.
- (ix) The Tenure Based Engagement will not confer any right on the Personnel to claim the status of a regular employee of the Company.

- (x) There will not be any commitment to the candidate either for absorption as permanent employee or for extension of term.
- (xi) The Tenure based Personnel will abide by various Company/Factory Rules & Regulations governing carrying out the assigned tasks and their conduct, like Standing Orders etc.
