- i. Applicant must fill the Google form available on the link provided by the hospital before coming for the Interview. The link will be also available on the hospital website. Last date of filling the Google form is 10.04.2026 till mid night.
- ii. The tentative dates of Interview is last week of April, 2026 Detailed scheduled will be shared on hospital website.
- iii. Applicant must bring print out of the Google form along with requisite documents in original and a set of photocopy on the date of Interview. No candidate will be allowed to appear in the Interview without filling the Google form.
- iv. Application lacking complete information as per the proforma as well as failure in submission of copies of relevant documents at the time of interview will be liable to rejection without any further communication.
- v. The appointment will be initially for a period of 05 years on the basis of satisfactory work and conduct report from Director, RGSSH being HOD. Further extension will be based on annual performance appraisal report as per MOA of the hospital.
- vi. The contract engagement shall not be pensionable.
- vii. 4% seats shall be reserved for DIVYANG (Person with Disability [PwD]) candidates on horizontal basis. However candidates are advised to apply as post suitability criteria/guidelines issued by DOPT and other competent body in this regard.

The current applicable salary for retired person is last basic pay drawn minus pension plus applicable DA.

A merit list of selected and wait listed candidates list will be prepared and same will be published on RGSS hospital website i.e. <https://rgssh.delhi.gov.in> as well as on website of Health & Family Welfare, Govt. of NCT of Delhi i.e. <https://health.delhi.gov.in> and no other method of communication shall be made.

After selection to the post, the registration with DMC mentioning their essential qualification for the selected post shall be mandatory.

Candidates seeking benefits of relaxation in age under SC/ST/OBC/PwD categories should produce the relevant certificates (issued on or before last date of application filling) issued by competent authority. In case of OBC candidate only non-creamy layer certificate issued within Six months period by competent authority of GOVT. of NCT of Delhi will be considered.
- iv. The candidates should not have been convicted by any court of law.
- v. Any canvassing by or on behalf of the candidate or any outside influence in any form with regard to selection will lead to disqualification of candidature.
- vi. The appointment will be liable for termination, if any declaration/information furnished found false or any material/fact is suppressed willfully.
