## WALK-IN-INTERVIEW FOR GDMOs & SPECIALIST DOCTORS IN SASHASTRA SEEMA BAL (SSB)

Sashastra Seema Bal (SSB) proposes to engage **General Duty Medical Officers (GDMOs) and Specialists** for medical services at various locations/formations throughout the country (purely on contract basis) as per terms and conditions mentioned below:-

### 1. Remuneration

The following consolidated remuneration per month will be admissible:-

- Rs.85,000/- for Specialists
- Rs.75,000/- for GDMOs

The contractual appointee shall not be entitled to any allowances, benefits or concessions as admissible to Govt. employees.

### 2. Age

A General Duty Medical Officer/Specialist so appointed shall not continue in the post once he/she attains 70 years of age.

### 3. Period of Engagement

- The initial contractual appointment shall be for a period of three years which may be extended by SSB on a yearly basis for a maximum period of two more years subject to the Specialist/ GDMO attaining the age of 70 years or till a regular incumbent joins the post, whichever is earlier.
- Services of the contractual appointee are liable to be terminated before the expiry of the contract period, by either side, after providing one month's notice and without assigning any reason thereof or by payment/refund of one month's salary.
- This contractual appointment neither bestows nor carries any right for regularization or permanent absorption in SSB or in any government department.

### 4. Leave

Leave entitlement of the appointee shall be governed as per DoP&T O.M. No. 12016/3/84E stt(L) dated 12th April 1985 and OM dated 5th July, 1990 as amended from time to time.

### 5. Admissibility of TA/DA and documentation

No TA/DA shall be admissible to the candidate to attend interview for appointment to the contractual posts. Suitable and willing candidates may **WALK IN FOR INTERVIEW** at the scheduled places along with original and photocopies of all relevant documents (like Graduation Degree, internship completion certificate, age proof, address proof and experience certificate, if any etc) and an application in plain paper superscripting the name of post applied for in the State/area/region and five recent passport size photographs. The appointment carries with it the liability to serve in any part of the country. The Director General SSB reserves the right to decide the place of posting of the contractual Specialist/GDMO.

6. Director General, SSB reserves the right to amend, modify, cancel or to change this advertisement in part or whole thereof without assigning any reason.

### 7. Educational/professional qualifications:-

#### (a) Specialists.

- A recognized medical qualification included in the First or Second Schedule or Part II of the Third Schedule (other than that licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in sub-section (3) of section (13) of the Indian Medical Council Act, 1956.
- Post-Graduate Degree/Diploma in the concerned Specialty as mentioned in Section-A or Section-B of Schedule-VI or equivalent.
- Experience:** 1½ years experience for Post Graduate degree holder & 2½ years for Diploma holder in the concerned specialty after obtaining the Post Graduate Degree/Diploma or equivalent.

#### (b) GDMOs.

- A recognized medical qualification included in the First or Second Schedule or Part II of the Third Schedule (other than that licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in sub section (3) of section (13) of the Indian Medical Council Act, 1956.
- Completion of compulsory rotating internship.

### 8. Medical Examination

Candidates applying for contractual appointment as Specialist/GDMO shall have to appear for interview and medical examination by a Board of Medical Officers detailed by concerned Composite Hospitals. Appointment shall be subject to Physical fitness.
